## MESSAGES FROM THE SENATE

Announcing the passage of **SBs 1207, 1211, 1371, 1422, 1453, 1474, 1510 and 1534**. The measures were introduced and read for the first time.

**SB 1207** – By Prieto, Hamilton and Bullard of the Senate and May of the House.

An Act relating to higher education; amending 70 O.S. 2021, Section 4104, which relates to degrees offered by private institutions; exempting from certain requirements religious degrees issued by certain institutions; requiring religious degrees and associated documents to contain certain modifier; providing an effective date; and declaring an emergency.

**SB 1211** – By Thompson (Kristen) of the Senate and George of the House.

An Act relating to domestic abuse; amending 21 O.S. 2021, Section 644, as last amended by Section 1, Chapter 212, O.S.L. 2023 (21 O.S. Supp. 2023, Section 644), which relates to assault and battery; modifying range of punishment for certain offense; updating statutory language; and providing an effective date.

**SB 1371** – By Paxton of the Senate and George of the House.

An Act relating to the Office of Homeland Security; amending 74 O.S. 2021, Sections 51.1, 51.1a, 51.2, and 51.2a, as amended by Sections 1, 2, 3, and 4, Chapter 302, O.S.L. 2022 (74 O.S. Supp. 2023, Sections 51.1, 51.1a, 51.2, and 51.2a), which relate to the Oklahoma Homeland Security Act; authorizing Commissioner of Public Safety to act as Homeland Security Advisor; stating responsibilities and duties; providing certain requirements of certain employees commissioned as peace officers; stating certain exemption; authorizing certain agreements; stating certain personnel and property allocations remain with the Office of Homeland Security; amending 74 O.S. 2021, Section 51.2b, as last amended by Section 3, Chapter 325, O.S.L. 2023 (74 O.S. Supp. 2023, Section 51.2b), which relates to the Oklahoma Homeland Security Act; requiring electronic submission of report; amending 74 O.S. 2021, Sections 51.2c, 51.2d, and 51.3, as amended by Sections 6, 7, and 8, Chapter 302, O.S.L. 2022 (74 O.S. Supp. 2023, Sections 51.2c,

51.2d, and 51.3), which relate to the Oklahoma Homeland Security Act; updating statutory references; amending 74 O.S. 2021, Section 51.4, which relates to the Oklahoma Homeland Security Act; transferring the Office of Homeland Security from the Oklahoma Department of Emergency Management to the Department of Public Safety; updating statutory language and references; and declaring an emergency.

**SB 1422** – By Pederson and Dossett of the Senate and Kerbs and Randleman of the House.

An Act relating to the Oklahoma Industrial Hemp Program; creating the Oklahoma Industrial Hemp Task Force; providing for termination; providing purpose; providing for membership; stating quorum; allowing election of chair and vice chair; requiring appointments and first meeting within certain time frame; disallowing compensation; providing staff; authorizing certain consultations; requiring certain report; providing for codification; and declaring an emergency.

**SB 1453** – By Rosino of the Senate and Newton of the House.

An Act relating to the Attorney General; amending 74 O.S. 2021, Section 30.5, as amended by Section 1, Chapter 75, O.S.L. 2022 (74 O.S. Supp. 2023, Section 30.5), which relates to definitions used in the Political Subdivisions Opioid Abatement Grants Act; broadening certain definitions; removing obsolete language; amending 74 O.S. 2021, Section 30.6, which relates to the Oklahoma Opioid Abatement Revolving Fund; authorizing the Office of the Attorney General to withhold and use certain funds for certain purposes; updating statutory reference; and providing an effective date.

**SB 1474** – By Thompson (Roger) of the Senate and Echols of the House.

An Act relating to alcoholic beverages; amending 37A O.S. 2021, Section 6-103, as last amended by Section 1, Chapter 200, O.S.L. 2023 (37A O.S. Supp. 2023, Section 6-103), which relates to prohibited acts of retail spirits licensees; removing certain prohibition; and providing an effective date.

**SB 1510** – By Hall and Boren of the Senate and Archer of the House.

An Act relating to the Energy Discrimination Elimination Act of 2022; amending Section 5, Chapter 231, O.S.L. 2022 (74 O.S. Supp. 2023, Section 12005), which relates to municipal and state agency contracts; deleting definition; modifying application of certain contract requirements; updating statutory reference; and declaring an emergency.

**SB 1534** – By Weaver of the Senate and O'Donnell of the House.

An Act relating to the Uniform Unclaimed Property Act; amending 60 O.S. 2021, Sections 661, 662, and 674.2, which relate to reports of abandoned property, notice and publication, and property delivered to State Treasurer; authorizing electronic communication under certain circumstances; increasing value for property for which the State Treasurer is not required to publish notice; increasing value of property for which claimant is required to provide certain documentation; updating statutory language; and providing an effective date.
