## MESSAGES FROM THE SENATE

Announcing the passage of **SBs 468, 1258, 1323** and **1617**. The measures were introduced and read for the first time.

**SB 468** – By Howard of the Senate and Kannady of the House.

An Act relating to estate planning; creating the Uniform Electronic Estate Planning Documents Act; providing short title; defining terms; construing provisions; stating scope of act; providing exception; providing for applicability of principles of law and equity; clarifying that use of electronic record or signature not required; prohibiting certain waiver; requiring recognition of electronic non-testamentary estate planning document or signature; establishing attribution and effect of electronic record and signature; establishing requirements for notarization and acknowledgement; authorizing electronic witnessing and attestation for certain documents; establishing requirements for retention of certain electronic records; providing exception; allowing additional requirements imposed by governmental agency; authorizing creation of certified paper copy of certain electronic documents; providing for admissibility of certain electronic documents or signatures; providing for uniformity of application and construction; clarifying relation to certain federal provisions; specifying applicability of provisions to certain electronic documents; providing for severability; and providing for codification.

**SB 1258** – By Pugh of the Senate and McBride of the House.

An Act relating to schools; amending 70 O.S. 2021, Section 1-117, which relates to a school district's general fund; updating statutory references; removing a requirement for the State Board of Education or State Board of Career and Technology Education to authorize certain expenditures; requiring a school district board of education to authorize certain expenditures; removing requirement for the State Board of Education to establish certain rules; updating statutory language; removing requirement for the Superintendent of Public Instruction to make certain certification; providing an effective date; and declaring an emergency.

**SB 1323** – By Thompson (Roger) and Hamilton of the Senate and Hilbert of the House.

An Act relating to district attorneys; amending 19 O.S. 2021, Section 215.29, which relates to district attorneys and assistant district attorneys; authorizing certain retired persons to retain certain items under certain conditions; authorizing transfer of certain items under certain circumstances; authorizing purchase of certain issued items; amending 19 O.S. 2021, Section 215.35A, which relates to district attorney investigators; authorizing certain retired persons to retain certain items under certain conditions; authorizing transfer of certain items under certain circumstances; authorizing purchase of certain issued items; updating statutory language; and providing an effective date.

**SB 1617** – By Thompson (Kristen) and Young of the Senate and Pfeiffer of the House.

An Act relating to municipal land; amending 11 O.S. 2021, Section 42-106.1, which relates to restrictive covenants on property; providing process for amendment of discriminatory restrictive covenants; declaring certain discriminatory restrictive covenants null and void; and providing an effective date.
