Fifteenth Legislative Day, Wednesday, February 28, 2024

MESSAGES FROM THE SENATE

Announcing the passage of **SBs 1296, 1340, 1438, 1491, 1516, 1521** and **1528**. The measures were introduced and read for the first time.

SB 1296 – By Rosino of the Senate and Newton of the House.

An Act relating to the Opioid Overdose Fatality Review Board; amending 63 O.S. 2021, Section 2-1002, which relates to composition and meetings of the Board; modifying required frequency of meetings; establishing quorum and certain voting threshold; updating statutory reference; updating statutory language; providing an effective date; and declaring an emergency.

SB 1340 – By Thompson (Roger) and Bullard of the Senate and Wallace of the House.

An Act relating to the Office of the Attorney General; creating the Federal Overreach and Extraordinary Litigation Revolving Fund; specifying source of fund; providing for expenditures; providing purpose of fund; providing for codification; providing an effective date; and declaring an emergency.

SB 1438 – By Rader of the Senate and Fetgatter of the House.

An Act relating to heavy equipment rental fees; defining terms; authorizing imposition of recovery fee with respect to heavy equipment; requiring retention of fee; specifying purpose of fee; providing certain transactions exempt from fee requirement; requiring submission of report; prohibiting imposition of sales tax on recovery fee amounts; amending 68 O.S. 2021, Section 1357, as last amended by Section 1, Chapter 344, O.S.L. 2023 (68 O.S. Supp. 2023, Section 1357), which relates to sales tax exemption; exempting recovery fees; updating statutory language; providing for codification; and providing an effective date.

SB 1491 – By Stanley of the Senate and Roe of the House.

An Act relating to sexually transmitted infections; amending 63 O.S. 2021, Section 1-522, which relates to treatment without prescription; providing certain exception; updating statutory language; defining terms; authorizing provision of expedited partner therapy under certain conditions; requiring provision of certain counseling; providing certain protections from civil liability and disciplinary action; specifying information to be included in certain materials; authorizing promulgation of rules; providing for codification; and providing an effective date.

SB 1516 – By Daniels of the Senate and Kane of the House.

An Act relating to medicolegal investigations; amending 63 O.S. 2021, Section 948.1, which relates to fee schedule; increasing certain fee range; clarifying applicability of certain fee; and providing an effective date.

SB 1521 – By Pemberton and Stephens of the Senate and Lowe (Dick) of the House.

An Act relating to schools; amending Section 1, Chapter 281, O.S.L. 2023 (70 O.S. Supp. 2023, Section 5-148.1), which relates to the School Resource Officer Program; directing certain school districts to give first priority to hiring certain law enforcement officers; allowing certain school districts to employ or contract with certain officers or security guards under certain circumstances; directing certain law enforcement agency to provide certain individual a radio system to be used in performance of certain duties; allowing use of certain fund for certain purpose; updating statutory reference; providing an effective date; and declaring an emergency.

SB 1528 – By Weaver of the Senate and Ford of the House.

An Act relating to the Interstate Compact for Adult Offender Supervision; amending 22 O.S. 2021, Section 1094, which relates to the Oklahoma State Council for Interstate Adult Offender Supervision; modifying voting membership of Council; updating statutory reference; and providing an effective date.

Representative Burns moved to amend **SB 941** by striking the title, the enacting clause, the entire bill and inserting in lieu thereof a floor substitute.

Representative Burns moved to amend the floor substitute, Page 21, Section 3, Lines 1 through 3 by deleting the language beginning with the "The" through the word "be" and inserting in lieu thereof the following: "These licenses shall be required for hunting in a commercial hunt area"; and Line 9 by inserting after the parentheticals and prior to the "." the following:"; and 4. Five-Day hunting license for nonresidents hunting winged upland game, excluding wild turkey, in a commercial hunting area – Fifteen Dollars (\$15.00)"., which amendment to the floor substitute was adopted.

Representative Burns moved to amend the floor substitute, Page 19, Section 3, Line 17 by inserting prior to the word "and" the following paragraph, "9. Five day youth hunting license for nonresidents under eighteen (18) years of age, which shall include all species and all seasons for which a hunting license is required – Seventy-five Dollars (\$75.00);" and by renumbering subsequent paragraphs, which amendment to the floor substitute was declared adopted.

Representative Burns pressed adoption of the floor substitute, as amended, which amendment was declared adopted.
