Supp. 2023, Section 712), which relates to employees of the Oklahoma Lottery Commission; removing prohibition of employee from certain employment following termination; updating statutory language; amending 3A O.S. 2021, Section 713, as last amended by Section 2, Chapter 332, O.S.L. 2023 (3A O.S. Supp. 2023, Section 713), which relates to the Oklahoma Education Lottery Trust Fund; removing

method of transfer of certain funds; modifying portion of annual appropriation; directing certain funds from the Oklahoma Education Lottery Trust Fund to go into certain funds; providing for method of apportionment to be transferred from fund into the specified funds; directing remainder of funds to be transferred into certain fund by certain date; updating statutory reference; repealing 3A O.S. 2021, Section 719, which relates to the Fidelity Revolving Fund; repealing 3A O.S. 2021, Section 732, which relates to negotiable bonds and promissory notes; and providing an effective date.

SB 1520 – By Pemberton and Stephens of the Senate and Hays of the House. SB 1539 – By Haste of the Senate and Vancuren of the House. An Act relating to schools; amending 70 O.S. 2021, Section 24-158, as amended by Section 2, Chapter 281, O.S.L. 2022 (70 O.S. SB 1624 – By Seifried of the Senate and Vancuren of the House. An Act relating to higher education; amending 70 O.S. 2021, Section 626.7, which relates to the Oklahoma Higher Education Tuition Aid Act; providing eligibility for certain programs; updating statutory language; updating statutory reference; providing an effective date; and declaring an emergency.

SB 1639 – By Prieto and Bullard of the Senate and Pae of the House. An Act relating to kratom products; amending 63 O.S. 2021, Section 1-1432.4, which relates to labeling requirements; modifying and adding labeling requirements for kratom products; and providing an effective date.

SB 1651 – By Pederson of the Senate and Patzkowsky of the House. An Act relating to schools; amending 70 O.S. 2021, Section 1-114, which relates to free attendance of public schools; updating statutory language regarding student transfers pursuant to certain act; exempting from certain tuition fee requirement school districts that

enroll certain students, do not receive certain funds, and have certain per-pupil expenditure; prohibiting certain students from being eligible for State Aid; prohibiting allocation or transfer of certain local funding; providing an effective date; and declaring an emergency.

SB 1663 – By Gollihare of the Senate and Duel of the House.

An Act relating to probation; authorizing the filing of a petition to request termination of probation; providing elements of petition; authorizing certain response from prosecuting entity within certain period; requiring evidentiary hearing within certain period; prohibiting certain fees for terminated probation; providing for codification; and providing an effective date.
