**SB 1512** – By Alvord of the Senate and Cantrell of the House.

An Act relating to county commissioners; amending 19 O.S. 2021, Section 165, as amended by Section 1, Chapter 317, O.S.L. 2023 (19 O.S. Supp. 2023, Section 165), which relates to travel allowance; authorizing the use of certain equipment by county commissioners; and declaring an emergency.

**SB 1514** – By Paxton of the Senate and Boles of the House.

An Act relating to the Commissioners of the Land Office; amending 52 O.S. 2021, Section 570.14, which relates to the Production Revenue Standards Act; providing certain statutes of limitations be applied to the Office; amending 64 O.S. 2021, Section 1073, which relates to oil and gas leases of the Office; conforming language; and providing an effective date.

**SB 1522** – By Pemberton and Haste of the Senate and Tedford of the House.

An Act relating to the State Board of Education; amending 70 O.S. 2021, Section 3-104, as last amended by Section 4, Chapter 323, O.S.L. 2023 (70 O.S. Supp. 2023, Section 3-104), which relates to powers and duties of the State Board of Education; removing certain definition; directing certain grants to be used for certain purposes; updating statutory language; repealing 70 O.S. 2021, Section 3-104, as amended by Section 1, Chapter 290, O.S.L. 2023, which relates to powers and duties of the State Board of Education; providing an effective date; and declaring an emergency.

An Act relating to noneconomic damages; amending 23 O.S. 2021, Section 61, which relates to obligation not arising from contract; prohibiting party from referencing noneconomic damages to jury in certain actions; and providing an effective date.

An Act relating to the Oklahoma Firefighters Pension and Retirement System; amending 11 O.S. 2021, Section 49-135, as amended by Section 8, Chapter 232, O.S.L. 2022 (11 O.S. Supp. 2023, Section 49-135), which relates to membership benefits and requirements; establishing provisions for return to service by certain members; providing for cessation of certain benefits during certain paid service; prohibiting certain disabled

members from returning to service; defining term; updating statutory language and reference; prohibiting further accrual of service; and providing an effective date.

**SB 1535** – By Burns and Rader of the Senate and Boles of the House.

An Act relating to the Oklahoma Low Carbon Energy Initiative; amending 17 O.S. 2021, Sections 802.2 and 802.3, as amended by Sections 1 and 2, Chapter 27, O.S.L. 2022 (17 O.S. Supp. 2023, Sections 802.2 and 802.3), which relate to the duties of the Initiative and the Oklahoma Low Carbon Energy Initiative Board membership; modifying duties and membership of the Board; requiring electronic reporting; updating statutory reference; and providing an effective date.
