Thirty-fifth Legislative Day, Monday, April 8, 2024

The House was called to order by Representative Hasenbeck.

The roll was called with 80 Members present.

GENERAL ORDER

SB 1921 by Rosino et al. of the Senate and Culver et al. of the House was read and considered.

Representative Caldwell (Trey) moved to amend **SB 1921** by striking the title and enacting clause, which amendment was declared adopted.

Representative Culver moved that **SB 1921** be advanced from General Order, which motion was declared adopted.
