Thirty-sixth Legislative Day, Tuesday, April 9, 2024

The House was called to order by Speaker Pro Tempore Hilbert.

The roll was called with 96 Members present.

The following Members were excused: Blancett, Conley, Dollens, Marti, Pittman.—5.

The Speaker Pro Tempore declared a quorum present.

Prayer was offered by Andrew Carlson, Assistant House Chaplain.

Invocation was offered by Oklahoma Army National Guard Chaplain, Captain David Jordan.

Speaker McCall recognized Major General Thomas H. Mancino, the Adjutant General of the Oklahoma National Guard.

Major General Mancino addressed the Joint Session.

Speaker McCall recognized Chief Master Sergeant Scott Irwin, Oklahoma National Guard.

Chief Master Sergeant Irwin read a Proclamation from Governor Stitt recognizing Oklahoma National Guard Appreciation Day.

Upon motion of Representative Echols, the Third Joint Session was ordered dissolved at 10:25 a.m.
