**Forty-seventh Legislative Day, Monday, April 29, 2024**

Enrolled House Bill No. **1553**

By: Moore of the House and Pemberton of the Senate

Pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Enrolled House Bill **1553**.

House Bill **1553** would increase the statutory maximum number of full-time-equivalent employees at the Teachers' Retirement System of Oklahoma from 52 to 58. Because I have not been presented with a compelling reason for the increase, my continuing commitment to slow the growth of government enjoins on me a duty to veto it.

For these reasons, I have vetoed Enrolled House Bill **1553**.

Enrolled House Bill No. **1712**

By: Marti of the House and Garvin of the Senate

Pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Enrolled House Bill **1712**.

House Bill **1712** would mandate health insurers to cover an insured for durable medical equipment and supplies as prescribed by a health care provider, regardless of whether they are in-network or out-of-network. This requirement is in place even if the health care provider determines that the durable medical equipment is not medically necessary. The result is unquestionably an increase in the cost of health insurance for all Oklahomans.

For these reasons, I have vetoed Enrolled House Bill **1712**.
