Advising of his veto of **HB 3194** on April 30, 2024. The veto message reads as follows:

To the Honorable Speaker of the House
and Members of the House of Representatives
Second Regular Session, Fifty-ninth Oklahoma Legislature

Enrolled House Bill No. **3194**

By: Newton of the House and Howard of the Senate

Pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Enrolled House Bill **3194**.

House Bill **3194** is government overreach at its finest. House Bill **3194** is an unfunded mandate which would require all permitted water wells to be equipped with a water meter that will cost thousands of dollars per meter. While forcing water meters on Oklahomans may seem innocuous, it is undoubtedly a violation of private landowners' rights and emboldens the government to continue down that path.

For these reasons, I have vetoed Enrolled House Bill **3194**.
