# The Wild Ride of Mark McBride

I would like to invoke constitutional privilege before I start, in case I say something I shouldn't. I'm not the speaker Echols is, but I won't take as long. Speaking was not my calling in life. There is so much to say and I will forget something. 12 years! Wow, it has went by so fast. How do you pack it all into a minute.

I found out Dr. Dirt is a real person. He had a tracker put on my truck and cameras placed on my home. There is a story some would like for me to tell about a possum and a pop bottle, but that's a story for another day.

For the last 11 years I've been trying to get Milner to go to Nicaragua with me to meet my Sandinistas Brothers. Speaking of that, my travels in the third world was part of the reason I got into politics. I thought Oklahoma politics could come in handy becoming a dictator of a third world country.

What have we accomplished over the last 12 years?

In 2018, Forrest Bennett and I worked behind the scenes, crossed the political aisle and worked to secure a deal the Democrats would agree with the majority of Republicans on.

We have \$400 million in Capitol assets, including restoration and deferred maintenance projects around the state through various pieces of legislation we have passed.

I've also been a huge proponent of protecting the state's oil and gas industry. This industry has been the bread and butter of Oklahoma's economy since statehood. With the move toward green energy, it's been important to me that we protect our main economic driver even while we consider smart approaches to broaden our energy portfolio. Fossil fuels built Oklahoma. I've embraced hydrogen and other energy initiatives that I think could improve and diversify our state's economy.

My goal was always to be Chair of Energy. But, I kept looking at education. I couldn't help but be a little troubled by the push to move dollars from our public schools to private. I'm a public school guy. I attended and graduated from public schools, and the majority of the constituents in my House district, and even those beyond kept approaching me asking me about funding for public education. I was appointed to serve as Chair of the House Appropriations & Budget Subcommittee for Education. I'm thankful to Speaker McCall for this opportunity.

During my time as Chair of A&B Ed, we've worked to increase teacher pay and overall funding for public education to record high levels. We've passed legislation creating scholarships for students entering our colleges of education, to address our teacher shortage. These include the Inspired to Teach program, signed into law in 2022. This grants scholarship funds to students pursuing a teaching degree. By the end of last year's legislative session, nearly 2,000 students applied, and 23 Oklahoma educator preparation programs reported a 53.28% increase in enrollments from fall 2022 to spring 2023.

I've represented Oklahoma on The Energy Council comprised of 13 states and four Canadian provinces. I currently serve on the Executive Board of Directors for the Energy Council. I also serve on the Board of Directors of the Southern States Energy Board and Advisory to the Hydrogen Alliance.

Away from the Legislature, I've long been involved in several areas of mission ministry and humanitarian aid. I've consulted with mission projects in Central America, Eastern Europe (Bosnia-Herzegovina) and Africa. I've traveled to many places, meeting with some of the world's most impoverished people. I've wept with those who weep, and I've celebrated with those who celebrate. This work has enriched my life and expanded my view of the richness and diversity of God's creation.

In my capacity as an Oklahoma State Representative, I have worked on and traveled to South Korea to help strengthen investment in the Oklahoma oil and gas industry and aerospace. As a member of the Oklahoma Hydrogen Task Force, I traveled to Germany to meet with pipeline companies and hydrogen producers. I have met with the Senate in Dublin, Ireland, on commerce between Oklahoma and Ireland, and met in London on the aerospace industry. I am involved with AIPAC and AIEF on U.S. Israeli policy and security. In August 2023, I traveled to Israel and met with officials over safety and security; 38 days later Hamas attacked the areas we visited. Again, I wept with my brothers and sisters who were devastated in these attacks. I'm also involved with OK Israel Exchange "OKIE".

Much of my travels have turned into legislation that strengthens Oklahoma's covenants and trade ties with our allies in other nations. This extends Oklahoma's reach into the world and brings the world into our lives in positive ways.

Now, to the "Four Horsemen" Charles, Jon and Terry.

I was never really involved in politics. My parents instilled in me my Christian faith. Dad told me not long ago he always knew I would make something out of myself just didn't know it would take so long.

Mom, Dad, Sister, Brother and kids.

Finally, I'm blessed to be married to the love of my life. My wife Jennifer and I got married in November 2014. Between us, we have a total of seven children, nine grandchildren and two worthless mutts – one of whom inspired Cali's Law, legislation that made the rescue animal the Oklahoma state pet, drawing attention to the need to adopt shelter animals. I lost a son at the age of 21 in a car accident.

It's been a privilege to serve the state of Oklahoma and the residents of House District 53. I can't quite imagine yet what life will be like when I'm no longer a member of the House of Representatives. But it's time for others to take charge.

We've passed good legislation that has improved conditions for public school teachers and students, that has strengthened our state's energy industry and that has expanded our trade ties around the world. I trust others who come behind us to build on this work and protect what we and others have accomplished.

I can't help but think of the words of the Apostle Paul to Timothy: "I've fought the good fight. I've finished the race. I've kept the faith."

I'm grateful to House staff and my legislative assistant and our communications team that has worked with me every step of the way to bring my legislation to completion.

I'll miss my colleagues and the work we do.

But you'll see me around.

It's been a wild ride, but I wouldn't trade it.
