MESSAGES FROM THE SENATE

Announcing the passage of **SBs 1209** and **1280**. The measures were introduced and read for the first time.

SB 1209 – By Pederson of the Senate and Dobrinski of the House.

An Act relating to special license plates; amending 47 O.S. 2021, Section 1135.1, as last amended by Section 1, Chapter 392, O.S.L. 2022 (47 O.S. Supp 2023, Section 1135.1), which relates to the issuance of special license plates; disallowing the Honorary Consul License Plate; updating statutory reference; and declaring an emergency.

SB 1280 – By Weaver and Stephens of the Senate and Manger of the House.

An Act relating to the Uniform Controlled Dangerous Substances Act; amending 63 O.S. 2021, Section 2-401, which relates to prohibited acts; modifying elements of certain felony offenses; updating statutory language; and providing an effective date.
