# MESSAGES FROM THE SENATE

Announcing the passage of **SBs 32, 41, 69, 287, 368** and **394**. The above measures were introduced and read for the first time.

**SB 32** – By Stanley of the Senate and Miller of the House.

An Act relating to the Oklahoma National Guard Educational Assistance Act; amending Section 1, Chapter 24, O.S.L. 2022 (70 O.S. Supp. 2024, Section 3231), which relates to creation of the act; directing certain assistance to include program fees and any other fees for courses; directing the Oklahoma State Regents for Higher Education and the Military Department of the State of Oklahoma to jointly review certain fees; allowing the State Regents to determine if certain fees are ineligible for program assistance; authorizing the Department to establish certain cap; modifying retention eligibility; authorizing the Department to establish a cap on certain program participation; modifying reasons for which an application for assistance may be denied; directing the Department to promulgate certain regulations; directing the State Regents and the Department to coordinate certain promulgation; updating statutory references; updating statutory language; providing an effective date; and declaring an emergency.

**SB 41** – By Burns of the Senate and West (Rick) of the House.

An Act relating to memorial highway and bridge designations; designating the PFC Lewis Othel Branscum Memorial Bridge; providing for codification; and providing an effective date.

**SB 69** – By Green of the Senate and Shaw of the House.

An Act relating to memorial highway and bridge designations; designating the SFC Tomas L. Avey Bronze Star and Purple Heart Recipient Memorial Highway; providing for codification; and providing an effective date.

**SB 287** – By Pugh of the Senate and Miller and Pae of the House.

An Act relating to income tax; amending 68 O.S. 2021, Sections 2357.302, 2357.303, and 2357.304, as amended by Section 2, Chapter 313, O.S.L. 2024 (68 O.S. Supp. 2024, Section 2357.304), which relate to income tax credit for qualified employers and employees in the aerospace sector; modifying tax years for which credit may be claimed; and providing an effective date.

**SB** 368 – By Guthrie of the Senate and Hildebrant of the House.

An Act relating to the Oklahoma Vessel and Motor Registration Act; amending 63 O.S. 2021, Section 4002, as amended by Section 199, Chapter 282, O.S.L. 2022 (63 O.S. Supp. 2024, Section 4002), which relates to definitions; modifying certain definition; updating statutory language; and providing an effective date.

**SB 394** – By Bergstrom of the Senate and Kendrix of the House.

An Act relating to public health and safety; amending 63 O.S. 2021, Section 91, as amended by Section 1, Chapter 90, O.S.L. 2023 (63 O.S. Supp. 2024, Section 91), which relates to the State Anatomical Board; extending sunset date; updating statutory language; updating statutory reference; providing an effective date; and declaring an emergency.
