#### MESSAGES FROM THE SENATE

Announcing the passage of **SBs 20, 658, 903** and **1031**. The above measures were introduced and read for the first time.

**SB 20** – By Guthrie of the Senate and Banning of the House.

An Act relating to utility vehicles; amending 47 O.S. 2021, Section 11-1116, which relates to self-propelled or motor-driven and operated vehicles; updating statutory language; modifying statutory reference; prohibiting certain vehicles exceeding specific speed when operated on streets and highways; modifying location for operation of certain vehicles; and providing an effective date.

**SB** 658 – By Daniels, Hamilton and Jett of the Senate and Crosswhite Hader of the House.

An Act relating to the Oklahoma Children's Code; prohibiting certain actions by the Department of Human Services in relation to adoptive and foster parents; providing certain construction; providing for codification; and providing an effective date.

**SB** 903 – By Rosino of the Senate and Stinson of the House.

An Act relating to the state Medicaid program; amending 63 O.S. 2021, Section 5009.2, which relates to the Advisory Committee on Medical Care for Public Assistance Recipients; adding specified member; updating statutory language; and providing an effective date.

**SB 1031** – By Daniels of the Senate and Moore of the House.

An Act relating to alcoholic beverage licenses; amending 37A O.S. 2021, Section 2-146, as amended by Section 2, Chapter 192, O.S.L. 2022 (37A O.S. Supp. 2024, Section 2-146), which relates to grounds for denial of certain licenses; modifying applicability of certain exception; and providing an effective date.
