# MESSAGES FROM THE SENATE

Announcing the passage of **SBs 216, 331** and **462**. The above measures were introduced and read for the first time.

# **SB 216** – By Bergstrom of the Senate and Miller of the House.

An Act relating to driver licenses; providing for extension of certain driver license; requiring mailing of driver license to certain individual; requiring Service Oklahoma and Department of Corrections to enter into certain agreement; authorizing rule promulgation; amending 47 O.S. 2021, Section 6-212, as amended by Section 73, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2024, Section 6-212), which relates to provisional licenses; modifying provisions related to license reinstatement; requiring certain notification; prohibiting certain eligibility; requiring Service Oklahoma to enter into certain agreements; requiring the Department of Corrections to provide certain assistance; authorizing promulgation of rules; removing obsolete language; amending 57 O.S. 2021, Section 513.3, as amended by Section 1, Chapter 64, O.S.L. 2022 (57 O.S. Supp. 2024, Section 513.3), which relates to the Sarah Stitt Act; updating statutory reference; providing for codification; and providing an effective date.

# **SB 331** – By Hines of the Senate and Stinson of the House.

An Act relating to schools; creating the Emerson Kate Cole Act; providing short title; amending 70 O.S. 2021, Section 1-116.3, which relates to school medication policies; updating statutory language; updating statutory reference; requiring a school employee to call 911 if Epinephrine is administered to a student; requiring notification of a parent or legal guardian if a student experiences a possible allergic reaction; requiring annual training for certain teachers and school employees; providing for content and method of training; providing for noncodification; providing an effective date; and declaring an emergency.

**SB 462** – By Weaver of the Senate and Manger of the House.

An Act relating to municipal police officers; authorizing retired municipal police officers to retain firearm and badge; requiring request in writing; providing exceptions; authorizing custody and possession of the firearm and badge to be awarded to family of deceased officer; providing for codification; and providing an effective date.
