An Act relating to the Commissioners of the Land Office; amending 64 O.S. 2021, Section 1023, which relates to properties owned by the Commissioners of the Land Office; updating statutory reference; requiring payment in lieu of ad valorem tax; providing method for computation of payment; requiring county assessor to provide information to the Commissioners of the Land Office by specified date; and providing an effective date.

SB 251 – By Gollihare of the Senate and Stinson of the House.

An Act relating to mental health and substance abuse services; amending Section 4, Chapter 201, O.S.L. 2023 (43A O.S. Supp. 2024, Section 2-312.4), which relates to awards from the County Community Safety Investment Fund; expanding types of evidence-based services that qualify for funds; establishing minimum allocation for county government or multi-county partnership; updating statutory references; providing an effective date; and declaring an emergency.

SB 269 – By Rader of the Senate and Luttrell of the House.

An Act relating to The Oklahoma State System of Higher Education; amending 62 O.S. 2021, Section 34.53, which relates to the Oklahoma State Finance Act; updating statutory reference; amending 70 O.S. 2021, Section 3206.6a, which relates to the master lease program; expanding annual transaction limit to include certain refunded projects; updating statutory language; and providing an effective date.

SB 391 – By Bergstrom of the Senate and Kendrix of the House.

An Act relating to public health and safety; amending 63 O.S. 2021, Sections 2-1001, as amended by Section 1, Chapter 91, O.S.L. 2023, and 2-1003 (63 O.S. Supp. 2024, Section 2-1001), which relate to the Opioid Overdose Fatality Review Board; transferring Board duties to the Office of the Attorney General; conforming language; requiring furnishing of certain reports; providing for designation of certain duties to certain employees and contractors; repealing 63 O.S. 2021, Section 2-1002, as amended by Section 1, Chapter 324, O.S.L. 2024 (63 O.S. Supp. 2024, Section 2-1002), which relates to membership of the Opioid Overdose Fatality Review Board; providing an effective date; and declaring an emergency.

SB 393 – By Bergstrom of the Senate and Kendrix of the House.

An Act relating to professions and occupations; amending 59 O.S. 2021, Section 1253, as amended by Section 1, Chapter 65, O.S.L. 2023 (59 O.S. Supp. 2024, Section 1253), which relates to the State Board of Licensed Social Workers; extending sunset date; providing an effective date; and declaring an emergency.

**SB 409** – By Pugh of the Senate and Caldwell (Chad) of the House.

SB 419 – By Daniels and Bullard of the Senate and Lepak of the House.

An Act relating to the Attorney General; amending 74 O.S. 2021, Section 18c, which relates to employment of attorneys; authorizing certain entities to employ or appoint attorneys; updating statutory language; updating statutory references; and providing an effective date.

SB 490 – By Gollihare of the Senate and Lawson of the House.

An Act relating to the Student Athlete Name, Image and Likeness Rights Act; amending 70 O.S. 2021, Sections 820.23, as last amended by Section 1, Chapter 85, O.S.L. 2024, 820.24, as amended by Section 3, Chapter 315, O.S.L. 2023, and 820.25, as last amended by Section 2, Chapter 85, O.S.L. 2024 (70 O.S. Supp. 2024, Sections 820.23, 820.24, and 820.25), which relate to compensation, professional representation, and limitations on agreements and contracts; modifying circumstances under which a postsecondary institution or authorized third party may provide certain representation or payment; prohibiting use of state funds for certain payment; construing provisions; prohibiting requirement of release of or license to use certain name, image, and likeness rights for certain purposes; removing time limit for certain disclosure; authorizing revocation or rescission of certain agreement or commitment under certain circumstances; prohibiting liability for certain revocation or rescission; modifying terms for extension of certain contracts; updating statutory language; and declaring an emergency.

SB 578 – By Coleman of the Senate and Kelley of the House.

An Act relating to incentives; amending 68 O.S. 2021, Section 4301, which relates to the Oklahoma Quality Events Incentive Act; extending period in which the act is effective; and declaring an emergency.

SB 600 – By Gollihare and Boren of the Senate and Moore of the House. An Act relating to court fees; amending 28 O.S. 2021, Section 152, as amended by Section 1, Chapter 237, O.S.L. 2022 (28 O.S. Supp. 2024, Section 152), which relates to flat fee schedule; increasing certain assessment; and providing an effective date. **SB** 752 – By Stewart of the Senate and Boles of the House.

An Act relating to county purchasing; amending 19 O.S. 2021, Section 1500.1, which relates to the authority of county purchasing agents; authorizing county purchasing agents to establish online bidding process with certain vendors; updating statutory language; providing an effective date; and declaring an emergency.

SB 786 – By Weaver and Hines of the Senate and George of the House.

An Act relating to crimes and punishments; amending 21 O.S. 2021, Section 1220, which relates to transporting intoxicating beverage; prohibiting certain consumption of marijuana; increasing certain fine; updating statutory language and references; and providing an effective date.

SB 927 – By Hicks of the Senate and Munson of the House.

An Act relating to the state Medicaid program; amending 63 O.S. 2021, Section 5030.1, which relates to the Medicaid Drug Utilization Review Board; modifying appointment procedure for certain members; updating statutory language; and providing an effective date.
