SB 860 – By Weaver of the Senate and Kannady of the House. An Act relating to the Uniform Controlled Dangerous Substances Act; amending 63 O.S. 2021, Section 2-204, as last amended by Section 3, Chapter 308, O.S.L. 2024 (63 O.S. Supp. 2024, Section 2-204), which relates to Schedule I substances; adding certain substance to Schedule I; and providing an effective date.

SB 920 – By Rosino of the Senate and Miller of the House. An Act relating to aerospace infrastructure; amending 3 O.S. 2021, Sections 101 and 102.1, as amended by Section 12, Chapter 126, O.S.L. 2023 (3 O.S. Supp. 2024, Section 102.1), which relate to the Airport Zoning Act; defining terms; requiring certain permit for construction within certain radius of a heliport or vertiport; amending 3 O.S. 2021, Section 421, as last amended by Section 15, Chapter 135, O.S.L. 2024 (3 O.S.
