**SB 1024** – By Bergstrom and Jett of the Senate and Kendrix of the House.

An Act relating to the Administrative Procedures Act; amending 75 O.S. 2021, Section 303, which relates to the procedure for adopting, amending, or repealing a rule; requiring agency to submit statement of scope prior to rulemaking; specifying contents of statement; requiring submission of statement to Secretary of State; requiring determinations by Secretary of State and Governor; prohibiting certain actions by certain employees prior to certain determination; providing for submission and publication of certain approved statement; establishing provisions for revision of statement of scope; providing for



expiration of certain statement of scope; prohibiting certain rulemaking following expiration; updating statutory language; providing an effective date; and declaring an emergency.

**SB 1054** – By Goodwin, Boren and Nice of the Senate and Lowe (Jason) of the House.

An Act relating to the Tulsa Reconciliation Education and Scholarship Program; amending 70 O.S. 2021, Sections 2621, 2623, and 2625, which relate to creation of and eligibility for the program; modifying eligibility for program; updating statutory language; increasing income limit for certain eligibility; exempting certain applicants from certain income limit; allowing certain form to be used to verify income; removing certain eligibility criteria; directing the Oklahoma State Regents for Higher Education to give first priority status to certain applicants; modifying process for verifying documentation of lineage; requiring application form to include certain language; directing awards to be made in certain specified manner; directing the State Regents to involve certain community advisory committee in selection process; providing for composition of and appointments to advisory committee; directing certain university president to submit a list of proposed members; directing advisory committee to review certain applications and make certain recommendations; directing the State Regents to select recipients from certain list; allowing certain remaining scholarship award funds to be used for certain purposes; directing certain applicants to always be given first priority status; and declaring an emergency.

Supp. 2024, Section 6050.3), which relates to the Out-of-Network Ambulance Service Provider Act; authorizing local governmental entities to submit certain rates to the Insurance Department; requiring the Department to establish and maintain certain database; modifying reimbursement rates and criteria for certain ambulance services; updating statutory reference; updating statutory language; and providing an effective date.

**SB 1076** – By Murdock of the Senate and Newton of the House.

An Act relating to the Administrative Workers' Compensation Act; amending 85A O.S. 2021, Section 2, which relates to definitions; modifying definitions; updating statutory language; updating statutory references; and providing an effective date.

**SB 1077** – By Murdock and Kern of the Senate and Strom and Kannady of the House.

An Act relating to fish and wildlife; amending 29 O.S. 2021, Section 7-602, which relates to transporting wildlife; adding exception; updating statutory language; and providing an effective date.

**SB 1115** – By Daniels of the Senate and Pfeiffer of the House.

An Act relating to nuisances; amending 50 O.S. 2021, Sections 2, 8, and 10, which relate to public nuisances, remedies, and civil action; prohibiting certain acts from being deemed public nuisance; clarifying applicable remedies in certain civil actions; requiring certain determination for liability in certain action; requiring determination of proximate cause for maintenance of certain action; and providing an effective date.
