The above measures were introduced and read for the first time.

SB 2 – By Green, Thompson and Seifried of the Senate and Pfeiffer of the House.

An Act relating to wind energy facilities; amending 17 O.S. 2021, Section 160.20, as amended by Section 21, Chapter 126, O.S.L. 2023 (17 O.S. Supp. 2024, Section 160.20), which relates to setback requirements; providing setback requirements for certain wind energy facility towers from certain dwellings and property boundaries; updating statutory language; and providing an effective date.

SB 54 – By Weaver of the Senate and George of the House.

An Act relating to motor vehicle safety; amending 47 O.S. 2021, Section 11-902, which relates to persons under the influence of alcohol or other intoxicating substance; modifying sentencing provisions for certain violations; modifying scope of certain offense; modifying scope of penalties for certain offense; updating statutory language and references; and providing an effective date.

SB 76 – By Daniels of the Senate and Worthen of the House.

An Act relating to parole; amending 57 O.S. 2021, Section 516, which relates to parole violators; authorizing parole revocation by certain entity; clarifying authority under certain circumstance; and providing an effective date.

SB 171 – By Kirt and Stanley of the Senate and Hilbert of the House.

An Act relating to the State Capitol Building; directing the Department of Public Safety to create and maintain security plan; amending 73 O.S. 2021, Sections 176 and 345, which relate to the permanent legislative liaison committee and the State Capitol Repair Expenditure Oversight Committee; disestablishing committees and directing appointment of certain personnel; amending 74 O.S. 2021, Sections 4101, 4102, as amended by Section 1, Chapter 15, O.S.L. 2024, 4103, 4104, 4105, 4108, and 4109 (74 O.S. Supp. 2024, Section 4102), which relate to the State Capitol Preservation Commission; modifying definitions; defining terms; modifying duties of the Commission; modifying Commission membership; establishing meeting and quorum requirements; modifying Commission processes; providing oversight duties; modifying duties of Capitol Architect and Curator; providing for duties of the Office of Management and Enterprise Services relating to the State Capitol Building; providing for maintenance and curation of State and Capitol Art Collection; exempting certain projects from competitive bidding requirements; updating statutory language; repealing 74 O.S. 2021, Sections 4106 and 4107, which relate to Commission cooperation and administrative requirements; providing for codification; and declaring an emergency.

SB 382 – By Bullard of the Senate and Stark of the House.

An Act relating to schools; amending 70 O.S. 2021, Section 1-114, as amended by Section 1, Chapter 258, O.S.L. 2024 (70 O.S. Supp. 2024, Section 1-114), which relates to the right to attend school; requiring a child to be toilet trained prior to enrolling in certain grade beginning in certain school year; requiring a parent or legal guardian to provide certain assurances on certain form; directing the State Department of Education to create certain process; defining term; providing contents of process; providing exemption for certain students; updating statutory language; providing an effective date; and declaring an emergency.

SB 447 – By Boren of the Senate and Sterling of the House.

An Act relating to state property; permitting residents to forage for nuts and edible plants or fungi on state-owned or state-managed property; providing exceptions; encouraging certain apparel during foraging; defining terms; limiting foraging in certain areas managed by the Department of Wildlife Conservation; providing for promulgation of rules; providing for codification; and providing an effective date.

SB 448 – By Hamilton of the Senate and Grego of the House.

An Act relating to wildlife; amending 29 O.S. 2021, Section 7-304, as amended by Section 1, Chapter 19, O.S.L. 2022 (29 O.S. Supp. 2024, Section 7-304), which relates to wildlife refuges and Wildlife Management Areas; requiring nonresident hunters to receive permission from the Oklahoma Wildlife Conservation Commission to use certain areas; authorizing the Commission to create certain system for permitting; requiring permit fee; providing for promulgation of rules; updating statutory language; and providing an effective date.

SB 491 – By Guthrie of the Senate and Hildebrant of the House.

An Act relating to the Oklahoma Open Meeting Act; amending 25 O.S. 2021, Section 307, as last amended by Section 3, Chapter 180, O.S.L. 2024 (25 O.S. Supp. 2024, Section 307), which relates to executive sessions; authorizing executive session for discussion of certain sale, lease, or acquisition; limiting parties allowed to participate in executive session for certain purposes; updating statutory reference; and providing an effective date.

SB 518 – By Alvord of the Senate and West (Kevin) of the House.

An Act relating to medical marijuana packaging; amending 63 O.S. 2021, Section 427.18, as last amended by Section 144, Chapter 452, O.S.L. 2024 (63 O.S. Supp. 2024, Section 427.18), which relates to packaging and labeling requirements; requiring certain labeling; and providing an effective date.

SB 531 – By Seifried of the Senate and Archer of the House.

[alcoholic beverages - licensees - requirements - refusal - action - rights and ownership interests - effective date]

SB 562 – By Alvord of the Senate and Miller and Ford of the House.

An Act relating to crimes and punishments; amending 21 O.S. 2021, Sections 1902 and 1903, which relate to the Bus Passenger Safety Act; modifying scope of certain definitions; adding definitions; expanding scope of unlawful acts; updating statutory language and references; and declaring an emergency.

SB 599 – By Hamilton, Bullard, Burns, Deever, Prieto, Standridge, McIntosh, Grellner, Wingard, Hines, Bergstrom, Murdock, Frix, Sacchieri, Woods and Guthrie of the Senate and Turner of the House.

An Act relating to crimes and punishments; amending 21 O.S. 2021, Section 843.5, as amended by Section 2, Chapter 151, O.S.L. 2024 (21 O.S. Supp. 2024, Section 843.5), which relates to child sexual abuse; modifying requirements for imposition of certain punishments; and providing an effective date.

SB 626 – By Howard of the Senate and Pfeiffer of the House.

An Act relating to the Security Breach Notification Act; amending 24 O.S. 2021, Sections 162, 163, 164, 165, and 166, which relate to definitions, duty to disclose breach, notice, enforcement, and application; modifying definitions; requiring notice of security breach of certain information; requiring notice to Attorney General under certain circumstances; specifying contents of required notice; providing exemptions from certain notice requirements; requiring confidentiality of certain information submitted to Attorney General; authorizing Attorney General to promulgate rules; clarifying compliance with certain notice requirements; modifying authorized civil penalties for certain violations; providing exemptions from certain liability; limiting liability for violations under certain circumstances; modifying applicability of act; updating statutory language; updating statutory references; and providing an effective date.

SB 628 – By Gillespie of the Senate and Hildebrant of the House.

An Act relating to firearms; amending 21 O.S. 2021, Section 1277, which relates to unlawful carry in certain places; modifying list of places in which carry is unlawful; providing an exception to certain prohibited act; authorizing municipalities to allow employees or public officials to carry firearms under certain circumstances; providing restrictions; defining term; providing construing provision; providing for the public display of firearms subject to policies; updating statutory language; and providing an effective date.

SB 641 – By Paxton of the Senate and Tedford of the House.

An Act relating to motor vehicle repair; creating the Oklahoma Motor Vehicle Consumer Protection Act; providing short title; defining terms; establishing certain hourly market rate for labor; directing Insurance Department to adjust certain hourly market rate for labor; prohibiting certain administrative charges from exceeding certain amount; establishing certain maximum daily storage rates; authorizing certain increase in certain maximum daily storage rates; providing certain exceptions; requiring certain written invoice; allowing adjustment of certain maximum daily storage rates; providing for codification; and providing an effective date.

SB 743 – By Gollihare, Alvord, Thompson, Green, Paxton, Stanley and Hall of the Senate and Lawson of the House.

An Act relating to criminal disturbance; amending 21 O.S. 2021, Sections 915 and 916, which relate to disturbance of religious meeting; specifying range of punishment for certain misdemeanor offense; establishing felony offense for certain convictions; specifying range of punishment for certain felony offense; modifying definitions; modifying elements of certain offense; updating statutory language; and declaring an emergency.

SB 745 – By Gillespie of the Senate and Moore of the House.

An Act relating to schools; amending 70 O.S. 2021, Section 5-132, as amended by Section 1, Chapter 162, O.S.L. 2024 (70 O.S. Supp. 2024, Section 5-132), which relates to adult high school completion; extending age of individuals allowed to complete high school; updating statutory language; allowing a school district that provides a full-time

virtual education program to provide instruction to persons up to certain age if the persons receive instruction by certain method; exempting certain students from being included in certain reports; providing an effective date; and declaring an emergency.

SB 747 – By Reinhardt of the Senate and Harris of the House.

An Act relating to the Oklahoma Discovery Code; amending 12 O.S. 2021, Sections 3226 and 3226.1, which relate to general discovery provisions and abusive discovery; removing certain affidavit requirement for persons receiving certain notice or subpoena; establishing grounds for good cause to issue protective order to prevent deposition of certain officers; requiring certain motion; requiring court to issue certain order; providing exceptions; authorizing limitation of scope of deposition of certain officers; authorizing vacating or modifying order under certain circumstances; and providing an effective date.

SB 751 – By Stewart of the Senate and Miller of the House.

An Act relating to the State Architectural and Licensed Interior Designers Act; amending 59 O.S. 2021, Section 46.21b, as amended by Section 16, Chapter 138, O.S.L. 2024 (59 O.S. Supp. 2024, Section 46.21b), which relates to building types subject to act; modifying certain construction value; updating statutory language; and providing an effective date.

SB 758 – By Thompson, Paxton and Seifried of the Senate and Moore and Caldwell (Chad) of the House.

An Act relating to schools; amending 70 O.S. 2021, Section 1-109, which relates to length of the school year; prohibiting a school district or charter school from counting certain days or portions of days when school is closed and virtual instruction is provided toward certain classroom instruction time requirement; defining term; providing circumstances under which school may be closed and certain amount of virtual instruction may count toward certain classroom instruction time requirement beginning in certain school year; providing certain exceptions; requiring publication and submission of certain annual report; providing for contents of report; updating statutory language; updating statutory reference; and declaring an emergency.

SB 777 – By Jett of the Senate and West (Rick) of the House.

An Act relating to wildlife; amending 2 O.S. 2021, Section 6-313, which relates to commingling with wild aquatic species; prohibiting certain sales; allowing certain harvest under certain conditions; authorizing the Department of Wildlife Conservation to manage certain conditions for certain possession; allowing the Department to manage certain transactions; providing for promulgation of rules; allowing the Oklahoma Department of Agriculture, Food, and Forestry to assess certain import fees under certain circumstances; requiring each shipment to possess certain certificate; amending 29 O.S. 2021, Section 2-115, which relates to definition of game fish; expanding definition; and providing an effective date.

An Act relating to higher education; prohibiting certain institutions of higher education from using state funds, property, or resources to support or require certain activities related to diversity, equity, and inclusion; requiring certain institutions of higher education to initiate certain review after certain date; providing for restructuring or elimination of certain unnecessary functions; providing certain construction; requiring certain institutions to submit certain annual certificate of compliance by certain date; providing for promulgation of rules; providing for codification; providing an effective date; and declaring an emergency.

SB 840 – By Hicks of the Senate and Moore of the House.

An Act relating to teachers; directing the Commission for Educational Quality and Accountability to promulgate rules establishing certain micro-credential; establishing minimum requirements for micro-credential; authorizing a certified teacher with certain micro-credential to assess students for and diagnose dyslexia; directing certain micro-credential to be reflected on certain certificate; providing for codification; providing an effective date; and declaring an emergency.

SB 870 – By Rader of the Senate and Williams and Blancett of the House.

An Act relating to children; creating the Accountability, Transparency, and Protection for Exploited Youth Act; providing short title; requiring certain individuals to report sexual misconduct or exploitation; creating felony offense; providing for penalties; requiring investigation reports to be forwarded to certain individuals; requiring certain notification by the district attorney; providing for certain civil liability and damages; stating certain negligence; providing for civil penalties; requiring the Office of Juvenile Affairs to provide annual training; directing the Office of Juvenile System Oversight to submit certain report; amending 10A O.S. 2021, Sections 2-6-102 and 2-6-110, which relate to juvenile records; striking reference to repealed section; permitting disclosure of certain records under certain circumstances; authorizing certain individuals to access certain records; limiting disclosure of documents; directing certain individuals to comply with confidentiality obligations; permitting a party to request judicial review; updating statutory reference; providing for codification; and providing an effective date.

An Act relating to crimes and punishment; amending 21 O.S. 2021, Section 13.1, as amended by Section 1, Chapter 151, O.S.L. 2024 (21 O.S. Supp. 2024, Section 13.1), which relates to required service of minimum percentage of sentence; modifying statutory references to certain criminal offenses; modifying name of certain unlawful act; adding certain criminal offense; amending 21 O.S. 2021, Section 540A, which relates to eluding peace officers; modifying certain penalty provisions; updating statutory language; and providing an effective date.

SB 1028 – By Alvord of the Senate and Miller of the House.

An Act relating to notaries public; amending 49 O.S. 2021, Sections 1 and 2, which relate to appointment and oath, signature, bond, and seal; requiring certain national criminal history record check; increasing certain fees and bond requirements for commission; updating statutory language; and providing an effective date.

Supp. 2024, Section 427.10), which relates to physician recommendations; updating statutory language; requiring creation and maintenance of certain registry; providing certain requirements for listing on registry; requiring promulgation of certain rules; and declaring an emergency.

SB 1074 – By Murdock and Kern of the Senate and Strom and Kannady of the House.

Supp. 2024, Section 4-120), which relates to cancellation of voter registrations; requiring cancellation of voter registration under certain circumstance; authorizing the Secretary of the State Election Board to conduct voter registration list comparison with certain entities; requiring provision of notice of non-citizenship to certain voter; requiring furnishing of proof of citizenship to certain county election board; providing for cancellation of voter registration under certain circumstance; defining term; authorizing promulgation of rules for certain purposes; amending 26 O.S. 2021, Section 7-103.2, as last amended by Section 2, Chapter 264, O.S.L. 2023 (26 O.S. Supp. 2024, Section 7-103.2), which relates to voter registration list; specifying qualifications for access to certain list; requiring application for certain access; prohibiting access to voter registration list for certain purpose; prohibiting transmission of list to certain foreign entities; providing for codification; and providing an effective date.
