Representative Fugate raised a Point of Order pursuant to House Precedent 6.8-4 that states the motion to rescind cannot be used to avoid final action.

The Presiding Officer ruled the point not well taken pursuant to House Rule 10.1(e) that provides for the motion to rescind. Mason's Manual Section 480 states that the motion to rescind is used to reverse a previous action after the time for consideration has passed. Mason's Manual also states in Section 61, "if a legislative body passes or refuses to pass a main motion, that motion is disposed of for the session unless the vote is reconsidered or rescinded." This language explicitly allows for the usage of the motion to rescind even if the action being rescinded would otherwise be final action. For these reasons, the motion to rescind is necessary to restore a measure to its earlier position, regardless of whether the measure has passed or failed, because there is no explicit House Rule that states a contrary outcome. Consequently, House Precedents 6.8-4 and 10.1-4, and others in conflict with these Rules are hereby overturned.

Representative Fugate appealed the ruling of the Presiding Officer receiving the required second of 1/15 of the membership.

"The question is, shall the decision of the Presiding Officer be the decision of the House? All those in favor signify by voting 'Aye'; those opposed 'Nay'. The vote is now in progress."
