Pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Enrolled House Bill **1543**.

The Conservation Commission should work in conjunction with the 84 local conservation districts across the state. This bill would significantly expand the authority of the statewide Conservation Commission at the expense of existing local input and control. On its own website, the Conservation Commission emphasizes that it delivers “locally-led, non-regulatory solutions to Oklahoma’s most complex conservation challenges.” This bill would change that.
