MESSAGES FROM THE SENATE

Announcing the passage of **SBs 1257, 1314, 1326, 1365** and **1932**. The measures were introduced and read for the first time.

SB 1257 – By Hamilton of the Senate and Turner of the House.

An Act relating to the Uniform Controlled Dangerous Substances Act; amending 63 O.S. 2021, Section 2-101, as last amended by Section 8, Chapter 343, O.S.L. 2025 (63 O.S. Supp. 2025, Section 2-101), which relates to definitions; modifying terms; amending 63 O.S. 2021, Section 2-204, as last amended by Section 3, Chapter 308, O.S.L. 2024 (63 O.S. Supp. 2025, Section 2-204), which relates to Schedule I; adding substance; amending 63 O.S. 2021, Section 2-208, which relates to Schedule III; adding substance; removing substance; conforming statutory language; and providing an effective date.

SB 1314 – By Jech of the Senate and Newton of the House.

An Act relating to groundwater use; amending 82 O.S. 2021, Section 1020.16, which relates to commercial drilling or plugging license; increasing cap of certain fund; increasing amount of allowable expenditures from certain fund; increasing amount by which certain funds must be transferred; updating statutory language; updating statutory reference; and providing an effective date.

SB 1326 – By Coleman of the Senate and Hall of the House.

An Act relating to liens; amending 42 O.S. 2021, Sections 196 and 197.1, which relate to the Self-Service Storage Facility Lien Act; permitting electronic delivery and acceptance of rental agreements; providing for mode of acceptance in certain circumstance; providing timeline for disposal and sale of certain property; providing notice requirements; making language gender neutral; updating statutory language; updating statutory references; and providing an effective date.

SB 1365 – By Frix of the Senate and Townley of the House.

An Act relating to the Oklahoma Central Purchasing Act; amending 74 O.S. 2021, Section 85.3A, as amended by Section 53, Chapter 228, O.S.L. 2022 (74 O.S. Supp. 2025, Section 85.3A), which relates to exempted entities; updating statutory language; adding certain exemption; exempting certain purchases made by the Oklahoma Tourism and Recreation Department from the Oklahoma Central Purchasing Act; exceeding certain amount; construing provisions; providing for codification; and declaring an emergency.

SB 1932 – By Murdock of the Senate and Newton of the House.

An Act relating to the Oklahoma Motor Carrier Safety and Hazardous Materials Transportation Act; authorizing certain representation in certain administrative hearing; providing for codification; and providing an effective date.
