Thirty-eighth Legislative Day, Thursday, April 9, 2026

The House was called to order by Representative Maynard.

The Presiding Officer ruled the point not well taken pursuant to House Rule 6.2(b)(5) which states "Legislative deadlines previously agreed to by the House of Representatives shall be inapplicable to measures introduced or authorized by the Speaker."

Speaker Hilbert moved to amend **HB 3705** by deleting the content of the entire measure and inserting in lieu thereof a floor substitute, which amendment was declared adopted.

Representative Caldwell (Chad) moved that **HB 3705** be advanced from General Order, which motion was declared adopted.
